## Academic Achievement (Current Student) Bachelor's Scholarship – September 2024

Summary	All current University of Phoenix degree students who are actively enrolled in a University of Phoenix bachelor's degree program who (i) have taken a minimum of 24 credits at the University of Phoenix and have at least 18 credits remaining in a University of Phoenix bachelor's degree program; (ii) have an aggregate GPA of 3.75 or higher (on a 4.0 scale) in their current bachelor's degree program; (iii) have not had an unapproved break in attendance greater than 14 days in the last 365 days except for an approved leave of absence as of the scholarship deadline; and apply for this Academic Achievement Bachelor's Scholarship (Current Students) – September 2024 ("Scholarship") prior to the deadline and post attendance in a class between September 1 <sup>st</sup> , 2024 and September 30 <sup>th</sup> , 2024 ("Initial Attendance Window") will have the opportunity to be considered for one of 15 scholarships worth up to a maximum of \$2,000 each, distributed over 20 courses. <b>NOTE:</b> Students must begin the admissions application prior to completing this scholarship application.
Application Deadline	The Scholarship application will be made available online on September 1 <sup>st</sup> , 2024. Applications must be completed and submitted online at www.phoenix.edu by 11:59pm MST September 30 <sup>th</sup> , 2024 ("Application Deadline"). Applications submitted after the Application Deadline will not be considered. No exceptions.
