## Academic Achievement (Current Student) Master's Scholarship – August 2024

Section	Description
Summary	All current University of Phoenix degree students who are actively enrolled in a University of Phoenix master's degree program who (i) have taken a minimum of 9 credits at the University of Phoenix and have at least 9 credits remaining in a University of Phoenix master's degree program; (ii) have an aggregate GPA of 3.85 or higher (on a 4.0 scale) in their current master's degree program; (iii) have not had an unapproved break in attendance greater than 14 days in the last 365 days except for an approved leave of absence as of the scholarship deadline; and apply for this Academic Achievement Master's Scholarship (Current Students) – August 2024 ("Scholarship") prior to the deadline and post attendance in a class between August 1st, 2024 and August 31st, 2024 ("Initial Attendance Window") will have the opportunity to be considered for one of 15 scholarships worth up to a maximum of \$2,000 each, distributed over 11 courses.  NOTE: Students must begin the admissions application prior to completing this scholarship application.
Application Deadline	The Scholarship application will be made available online on August 1 <sup>st</sup> , 2024. Applications must be completed and submitted online at www.phoenix.edu by 11:59pm MST August 31 <sup>st</sup> , 2024 ("Application Deadline"). Applications submitted after the Application Deadline will not be considered. No exceptions.
Eligibility Criteria	<ol> <li>Applicants currently residing in the United States must meet one of the following requirements: be a legal resident of the United States; have been granted permanent residency; have a valid visa that does not prohibit educational studies; have been granted temporary protected status along with approved Notice of Action issued by Citizen Immigration Services and verified through CIS Form g-845; or have been granted asylum along with the approved Notice of Action issued by the Citizen Immigration Services.</li> <li>Applicant must meet all admissions requirements of University of Phoenix if selected as a scholarship recipient.</li> <li>Applicant must not be an employee (including full- and part-time faculty) or a family member (spouse, dependent child, or domestic partner) of an employee of University of Phoenix or any other affiliate of University of Phoenix, Inc.</li> <li>Applicant must be currently attending a University of Phoenix master's degree program.</li> <li>Applicant must submit a complete, signed application, together with all supporting documentation by the Application Deadline. Applicant must be actively enrolled and attending the University of Phoenix for a master's degree program within the Initial Attendance Window.
