Application	The Scholarship application will be made available online on October 1 st , 2024.
Deadline	Applications must be completed and submitted online at www.phoenix.edu by 11:59pm MST October 31 st , 2024 ("Application Deadline"). Applications submitted after the Application Deadline will not be considered. No exceptions.
Eligibility Criteria	 Applicants currently residing in the United States must meet one of the following requirements: be a legal resident of the United States; have been granted permanent residency; have a valid visa that does not prohibit educational studies; have been granted temporary protected status along with approved Notice of Action issued by Citizen Immigration Services and verified through CIS Form g-845; or have been granted asylum along with the approved Notice of Action issued by the Citizen Immigration Services. Applicant must meet all admissions requirements of University of Phoenix if selected as a scholarship recipient. Applicant must not be an employee (including full- and part-time faculty) or a family member (spouse, dependent child, or domestic partner) of an employee of University of Phoenix or any other affiliate of University of Phoenix, Inc. Applicant must be currently attending a University of Phoenix master's degree program.
