Summary	All new University of Phoenix bachelor's degree alumni students who (i) apply for and enroll in a University of Phoenix master's degree program; (ii) have an aggregate GPA of 3.25 or higher (on a 4.0 scale) in their University of Phoenix associate's degree; and (iii) apply for this Forever a Phoenix® Master's Scholarship – October 2024 ("Scholarship") prior to the deadline and register and post attendance in their first class between October 1st, 2024 and October 31st, 2024 ("Initial Attendance Window") will have the opportunity to be considered for one of twenty-five (25) scholarships worth up to a maximum of \$2,000 each, distributed over 11 courses. Eligibility Criteria	 Applicants currently residing in the United States must meet one of the following requirements: be a legal resident of the United States; have been granted permanent residency; have a valid visa that does not prohibit educational studies; have been granted temporary protected status along with approved Notice of Action issued by Citizen Immigration Services and verified through CIS Form g-845; or have been granted asylum along with the approved Notice of Action issued by the Citizen Immigration Services. Applicant must meet all admissions requirements of University of Phoenix if selected as a scholarship recipient. Applicant must not be an employee (including full- and part-time faculty) or a family member (spouse, dependent child, or domestic partner) of an employee of University of Phoenix or any other affiliate of University of Phoenix, Inc. Applicant must apply and be admitted to a University of Phoenix master's degree program. Applicant must submit a complete, signed application, together with all supporting documentation by the Application Deadline.
