Selection Process	 The recipients of the scholarships will be selected by the University of Phoenix. It is the applicant's responsibility to submit a complete and signed application along with any required and supporting documentation, which must be received on or before the Application Deadline. The Scholarship shall be disbursed as a credit toward the student's tuition payments at a rate of \$375 per course beginning with the student's first attended course and thereafter for up to eight courses for those continuously attended courses in their doctoral program until: (i) the student has maximized the \$3,000 Scholarship amount, or (ii) two years (730 days) has elapsed from the student's first course start date notwithstanding any approved leave of absence(s), or (iii) the student graduates from their program, whichever comes first. Subsections (i)-(iii) are collectively hereinafter referred to as "Terminating Events". Only the applicants selected as Scholarship recipients will be notified by the University of Phoenix. 					
Maintenance Requirements	 In order to continue disbursement of the scholarship award, applicant must meet the following maintenance requirements: Applicant must remain in a doctoral program (all coursework attended must be program applicable courses). Awards will only be applied to courses taken as part of their doctoral program, specific to the original program level award. Applicant must successfully pass each course attempted in accordance with their program's requirements as outlined in the academic catalog for all courses.
