## The Spring Transfer Student Bachelor's Scholarship – February 2025

Summary	All new or re-enroll (out of attendance for > 365 days) students who transfer to the University of Phoenix and who (i) apply for and enroll in a University of Phoenix bachelor's degree program; (ii) have completed and transfer in at least 12 but no more than 60 credits combined transfer credits from accredited institution(s); and (iii) apply for this Transfer Student Bachelor's Scholarship — February 2025 ("Scholarship") prior to the deadline and register and post attendance in their first class between February 1st, 2025 and February 28th, 2025 ("Initial Attendance Window") will receive a scholarship worth up to a maximum of \$3,000 each, distributed over twenty courses.  NOTE: Students must begin the admissions application prior to completing this scholarship application.				
Application Deadline	The Scholarship application will be made available online on January 1 <sup>st</sup> , 2025. Applications must be completed and submitted online at www.phoenix.edu by 11:59pm MST February 28 <sup>th</sup> , 2025 ("Application Deadline"). Applications submitted after the Application Deadline will not be considered. No exceptions.				
Eligibility Criteria	<ol> <li>Applicants currently residing in the United States must meet one of the following requirements: be a legal resident of the United States; have been granted permanent residency; have a valid visa that does not prohibit educational studies; have been granted temporary protected status along with approved Notice of Action issued by Citizen Immigration Services and verified through CIS Form g-845; or have been granted asylum along with the approved Notice of Action issued by the Citizen Immigration Services.</li> <li>Applicant must meet all admissions requirements of University of Phoenix if selected as a scholarship recipient.</li> <li>Applicant must not be an employee (including full- and part-time faculty) or a family member (spouse, dependent child, or domestic partner) of an employee of University of Phoenix or any other affiliate of University of Phoenix, Inc.</li> <li>Applicant must apply and be admitted to a University of Phoenix bachelor's degree program.</li> <li>Applicant must submit a complete, signed application, together with all supporting documentation by the Application Deadline.
