## The Transfer Student Bachelor's Scholarship – January 2025

Section	Description
Summary	All new students who transfer to the University of Phoenix and who (i) apply for and enroll in a University of Phoenix bachelor's degree program; (ii) have completed and transfer in at least 12 but no more than 60 credits combined transfer credits from accredited institution(s); and (iii) apply for this Transfer Student Bachelor's Scholarship – January 2025 ("Scholarship") prior to the deadline and register and post attendance in their first class between January 1st, 2025 and January 31st, 2025 ("Initial Attendance Window") will receive a scholarship worth up to a maximum of \$3,000 each, distributed over twenty courses.  NOTE: Students must begin the admissions application prior to completing this scholarship application.
Application Deadline	The Scholarship application will be made available online on December 1 <sup>st</sup> , 2024. Applications must be completed and submitted online at www.phoenix.edu by 11:59pm MST January 31 <sup>st</sup> , 2025 ("Application Deadline"). Applications submitted after the Application Deadline will not be considered. No exceptions.
Eligibility Criteria	<ol> <li>Applicants currently residing in the United States must meet one of the following requirements: be a legal resident of the United States; have been granted permanent residency; have a valid visa that does not prohibit educational studies; have been granted temporary protected status along with approved Notice of Action issued by Citizen Immigration Services and verified through CIS Form g-845; or have been granted asylum along with the approved Notice of Action issued by the Citizen Immigration Services.</li> <li>Applicant must meet all admissions requirements of University of Phoenix if selected as a scholarship recipient.</li> <li>Applicant must not be an employee (including full- and part-time faculty) or a family member (spouse, dependent child, or domestic partner) of an employee of University of Phoenix or any other affiliate of University of Phoenix, Inc.</li> <li>Applicant must not have previously attended University of Phoenix.</li> <li>Applicant must apply and be admitted to a University of Phoenix bachelor's degree program.</li> <li>Applicant must submit a complete, signed application, together with all supporting documentation by the Application Deadline. 	amount, or (ii) two years (730 days) has elapsed from the student's first course start date notwithstanding any approved leave of absence(s), or
	(iii) the student graduates from their program, whichever comes first.
